

UTS Prize Conditions of Award Zonta Club of Sydney Breakfast Award

Faculty: Engineering and Information Technology

This document sets out the conditions of award for the below prize ('Prize') and the obligations of recipients ('Recipient') and the University of Technology Sydney ('UTS') in regards to this Prize. The administrative processes to support awarding this Prize will be managed, and may be amended, in accordance with UTS Rules, Policy and Procedures.

1. PRIZE: Zonta Club of Sydney Breakfast Award

2. PURPOSE

The Prize was established in 2002 to provide financial support to a female identifying student enrolled in either Engineering or Information Technology undergraduate degree to promote greater participation by women in either discipline. The award supports one of the key objectives of Zonta International which is to improve the economic and educational status of women around the world.

3. VALUE AND BENEFIT

3.1 Number of Recipients:

One (1) Recipient will be awarded the Prize each year.

3.2 Benefit/s to Recipient:

- The value of the Prize to the Recipient is \$1,000
- A Certificate of Award.

3.3 Payment of benefit/s:

- The Recipient will receive one payment of \$1,000 by cheque, presented at the Zonta Club Sydney Breakfast award event; and
- A Certificate of Award.

4. ELIGIBILITY CRITERIA

To be eligible for the prize, the Recipient must:

- Be an Australian or New Zealand citizen, or the holder of an Australian permanent resident visa or permanent humanitarian visa, and
- Be female-identifying, and
- Be enrolled in one of the Faculty of Engineering and Information Technology undergraduate degree courses, including combined courses, and
- Have completed a minimum of 48 credit points, and no more than 144 credit points
- Have a minimum Weighted Average Mark (WAM) of 75 or greater at the time of application; and
- Submit the Prize application form; and
- Be available to attend an interview in-person or on-line, if required.
- Previous Recipients of the award are not eligible to apply again.

5. RECIPIENT SELECTION CRITERIA, IN PRIORITY ORDER

Applicants will be assessed by the Selection Committee on the basis of the following criteria:

• Demonstrated commitment to supporting women in engineering and/or information technology;

- The Recipient's experience of Engineering and/or Information Technology and ideas about how to increase the participation of women in either discipline;
- Extra-curricular activities that demonstrate leadership potential and contribution to the wider community;
- Academic excellence in their Engineering or Information Technology undergraduate degree.

6. SELECTION

A Selection Committee will be Chair of the Dean of the Faculty of Engineering and IT (or nominee) and one (1) relevant UTS academic, and at least one (1) representative of the Zonta Club of Sydney Breakfast Inc will be invited to participate on the selection committee. The Selection Committee will rank applicants on the on the basis of the Prize Selection Criteria.

The Selection Committee may choose to award the Prize to the top ranked applicant or may choose to invite the top ranked applicants to an interview with the Selection Committee. The Selection Committee will then select the Recipient of the Prize on the based on the outcome of the interview

The successful applicant will then be formally approved by the Dean, Faculty of Engineering and Information Technology by Executive Action on behalf of Faculty Board.

7. OTHER CONDITIONS

Previous Recipients of the award are not eligible to apply again.
